## **INFORMATION ON OBTAINING CLE CREDIT**

The Commission has already submitted attendance information to the State Bar of Georgia's CLE Department for Georgia Bar members. To maintain the CLE credit on your CLE transcript, please visit [www.gabar.org](http://www.gabar.org) and click on the "Member Login" Button in the top right-hand corner. After you are logged in, look for the Blue "My Account" Box to the left. Click on the first link, "CLE Status." You have the option to pay the \$4 per CLE hour fee to have the CLE remain on your transcript.

**Using the honor system, the Commission respectfully requests that you only pay for any CLE hours that you actually attended, if you did not attend all 2 hours of the CLE.**

The fee is not due until December 31st, so please do not be alarmed if you do not immediately see an amount due on your transcript that allows you to pay. If you do not see the CLE on your transcript after April 2, 2021, please e-mail [kygrier@cjcpga.org](mailto:kygrier@cjcpga.org).

If you are a member of the State Bar of Georgia and you want CLE credit in a state other than Georgia, you will need to contact that state directly to apply for CLE approval for the course.
