

To the opposing parties and their counsel, I offer fairness, integrity, and **civility**. I will seek reconciliation and, if we fail, I will strive to make our dispute a dignified one.

To the courts, and other tribunals, and to those who assist them, I offer respect, candor, and courtesy. I will strive to do honor to the search for justice.

A Lawyer's Creed (continued)

To my colleagues in the practice of law, I offer concern for your welfare. I will strive to make our association a professional friendship.

To the profession, I offer assistance. I will strive to keep our business a profession and our profession a calling in the spirit of public service.

To the public and our systems of justice, I offer service. I will strive to improve the law and our legal system, to make the law and our legal system available to all, and to seek the common good through the representation of my clients.

Aspirational Statement on Professionalism

The Court believes there are unfortunate trends of **commercialization and loss of professional community** in the current practice of law. These trends are manifested in an undue emphasis on the financial rewards of practice, **a lack of courtesy and civility among members of our profession**, a lack of respect for the judiciary and for our systems of justice, and **a lack of regard for others and for the common good**. As a community of professionals, we should strive to make the internal rewards of service, craft, and character, and not the external reward of financial gain, the primary rewards of the practice of law.

Aspirational Statement on Professionalism (continued)

In our practices we should remember that **the primary justification for who we are and what we do is the common good** we can achieve through the **faithful representation of people who desire to resolve their disputes in a peaceful manner and to prevent future disputes**. We should remember, and we should help our clients remember, that the way in which our clients resolve their disputes defines part of the character of our society and we should act accordingly.

Aspirational Statement on Professionalism (continued)

As professionals, we need aspirational ideals to help **bind us together in a professional community**. Accordingly, the Court issues the following Aspirational Statement setting forth general and specific aspirational ideals of our profession. This statement is a beginning list of the ideals of our profession. It is primarily illustrative. ***Our purpose is not to regulate, and certainly not to provide a basis for discipline, but rather to assist the Bar's efforts to maintain a professionalism that can stand against the negative trends of commercialization and loss of community.***

Aspirational Statement on Professionalism (continued)

It is the Court's hope that Georgia's lawyers, judges, and legal educators will use the following aspirational ideals to reexamine the justifications of the practice of law in our society and to consider the implications of those justifications for their conduct. The Court feels that enhancement of professionalism can be best brought about by the cooperative efforts of the organized bar, the courts, and the law schools with each group working independently, but also jointly in that effort.



General Aspirational Ideals

As a lawyer, I will aspire:

- To put **fidelity** to clients and, through clients, to the common good, before selfish interests.
- To model for others, and particularly for my clients, the respect due to those we call upon to resolve our disputes and the regard due to all participants in our dispute resolution processes.

Fidelity – Truth – Faithfulness



fi·del·i·ty |fə'delətē|

noun

faithfulness to a person, cause, or belief, demonstrated by continuing loyalty and support : *he sought only the strictest fidelity to justice.*

- the degree of exactness with which something is copied or reproduced : *the 1949 recording provides reasonable fidelity.*

As a lawyer, I will aspire (continued):

- To avoid all forms of wrongful discrimination in all of my activities including discrimination on the basis of race, religion, sex, age, handicap, veteran status, or national origin. The social goals of equality and fairness will be personal goals for me.
- To preserve and improve the law, the legal system, and other dispute resolution processes as instruments for the common good.

As a Lawyer, I will aspire (continued):

- To make the law, the legal system, and other dispute resolution processes available to all.
- To practice with a personal commitment to the rules governing our profession and to encourage others to do the same.
- To preserve the dignity and the integrity of our profession by my conduct. The dignity and the integrity of our profession is an inheritance that must be maintained by each successive generation of lawyers.

As a Lawyer, I will aspire (continued):

- To achieve the excellence of our craft, especially those that permit me to be the moral voice of clients to the public in advocacy while being the moral voice of the public to clients in counseling. Good lawyering should be a moral achievement for both the lawyer and the client.
- To practice law not as a business, but as a calling in the spirit of public service.

- To **expeditious and economical achievement** of all client objectives.
- To **fully informed client decision-making**. As a professional, I should:
 - Counsel clients about all forms of dispute resolution;
 - Counsel clients about the **value of cooperation** as a means towards the productive resolution of disputes;

As a professional, I should (continued):

- Maintain the sympathetic detachment that permits objective and independent advice to clients;
- Communicate promptly and clearly with clients; and,
- Reach clear agreements with clients concerning the nature of the representation.

As to clients, I will aspire (continued):

To **fair and equitable fee agreements**. As a professional, I should:

- Discuss alternative methods of charging fees with all clients;
- Offer fee arrangements that reflect the true value of the services rendered;
- Reach agreements with clients as early in the relationship as possible;
- Determine the amount of fees by consideration of many factors and not just time spent by the attorney;
- Provide written agreements as to all fee arrangements; and
- Resolve all fee disputes through the arbitration methods provided by the State Bar of Georgia.

As to clients, I will aspire (continued):

- To comply with the **obligations of confidentiality** and the **avoidance of conflicting loyalties** in a manner designed to achieve the **fidelity** to clients that is the purpose of these obligations.

As to opposing parties and their counsel, I will aspire:

- To cooperate with opposing counsel in a manner consistent with the competent representation of all parties. As a professional, I should:
 - **Notify opposing counsel in a timely fashion of any cancelled appearance;**
 - **Grant reasonable requests for extensions or scheduling changes;** and,
 - **Consult with opposing counsel** in the scheduling of appearances, meetings, and depositions.

As to opposing parties and their counsel, I will aspire (continued):

- To treat opposing counsel in a manner consistent with his or her professional obligations and consistent with the dignity of the search for justice. As a professional, I should:
 - Not serve motions or pleadings in such a manner or at such a time as to preclude opportunity for a competent response;
 - Be courteous and civil in all communications;
 - Respond promptly to all requests by opposing counsel;

As to opposing parties and their counsel, I will aspire (continued):

- Avoid rudeness and other acts of disrespect in all meetings including depositions and negotiations;
- Prepare documents that accurately reflect the agreement of all parties; and
- Clearly identify all changes made in documents submitted by opposing counsel for review.

General Aspirational Ideals

As to the courts, other tribunals, and to those who assist them, I will aspire:

- To represent my clients in a manner consistent with the proper functioning of a fair, efficient, and humane system of justice. As a professional, I should:
 - **Avoid** non-essential litigation and **non-essential pleading in litigation**;
 - **Explore the possibilities of settlement** of all litigated matters;
 - Seek non-coerced agreement between the parties on procedural and discovery matters;

As to the courts, other tribunals, and to those who assist them, I will aspire (continued):

- Avoid all delays not dictated by a competent presentation of a client's claims;
- Prevent misuses of court time by verifying the availability of key participants for scheduled appearances before the court and by being punctual; and
- Advise clients about the obligations of civility, courtesy, fairness, cooperation, and other proper behavior expected of those who use our systems of justice.

As to the courts, other tribunals, and to those who assist them, I will aspire (continued):

- To model for others the respect due to our courts. As a professional I should:
 - Act with **complete honesty**;
 - Know **court rules and procedures**;
 - Give **appropriate deference** to court rulings;
 - Avoid **undue familiarity with members of the judiciary**;

As to the courts, other tribunals, and to those who assist them, I will aspire (continued):

- Avoid unfounded, unsubstantiated, or unjustified public criticism of members of the judiciary;
- Show respect by attire and demeanor;
- Assist the judiciary in determining the applicable law; and,
- Seek to understand the judiciary's obligations of informed and impartial decision-making.

As to the public and our systems of justice, I will aspire:

- To counsel clients about the moral and social consequences of their conduct.
- To consider the effect of my conduct on the image of our systems of justice including the social effect of advertising methods.

As to the public and our systems of justice, I will aspire (continued):

As a professional, I should ensure that and advertisement of my services:

- is consistent with the dignity of the justice system and a learned profession;
- provides a beneficial service to the public by providing accurate information about the availability of legal services;
- educates the public about the law and legal system;
- provides completely honest and straightforward information about my qualifications, fees, and costs; and
- does not imply that clients' legal needs can be met only through aggressive tactics.

As to the public and our systems of justice, I will aspire (continued):

- To provide the **pro bono representation** that is necessary to make our system of justice available to all.
- To support organizations that provide pro bono representation to indigent clients.
- To improve our laws and legal system by, for example:
 - Serving as a **public official**;
 - Assisting in the **education of the public** concerning our laws and legal system;
 - **Commenting publicly upon our laws**; and,
 - Using other **appropriate methods of effecting positive change** in our laws and legal system.
