### CHIEF JUSTICE DAVID E. NAHMIAS



Chief Justice David E. Nahmias (pronounced "NAH-mee-iss") was appointed to the Supreme Court of Georgia in August 2009 by Governor Sonny Perdue. In November 2010, after a statewide campaign against two opponents, Chief Justice Nahmias was elected to a full six-year term on the Court. In 2016, he was re-elected to another six-year term without opposition.

The son of immigrants from Egypt and Germany, Chief Justice Nahmias was born in Atlanta on September 11, 1964. He attended Briarcliff High School in DeKalb County and was the state's STAR student in 1982. He attended Duke University, where he graduated second in his class and summa cum laude, and Harvard Law School, where he graduated magna cum laude and was a classmate of U.S. Supreme Court Justice Neil Gorsuch and an editor of the Harvard Law Review along with former President Barack Obama. Chief Justice Nahmias then served as a law clerk for Judge Laurence H. Silberman of the U.S. Circuit Court for the District of Columbia and for Justice Antonin Scalia of the U.S. Supreme Court.

After practicing with a large law firm in Washington, D.C., in 1995 Chief Justice Nahmias joined the U.S. Attorney's Office in Atlanta. As a federal prosecutor, he worked extensively on the investigation of the Centennial Olympic Park and subsequent bombings committed by Eric Robert

Rudolph. He also worked on a number of major fraud and public corruption cases, including the successful prosecutions of a Georgia state senator and numerous City of Atlanta and Fulton County public officials and contractors.

Shortly after the September 11, 2001 terrorist attacks, Chief Justice Nahmias returned to Washington and became one of the Justice Department's leading terrorism prosecutors, coordinating the investigation and prosecution of terrorist activity across the country and internationally and assisting in counter-terrorism policymaking. After being promoted to Deputy Assistant Attorney General for the Criminal Division, Chief Justice Nahmias supervised the Fraud Section, the Appellate Section, and the Capital Case Unit, in addition to the Counterterrorism Section.

On December 1, 2004, after being nominated by President George W. Bush and unanimously confirmed by the U.S. Senate, Chief Justice Nahmias returned home as the United States Attorney for the Northern District of Georgia – the chief federal law enforcement officer for the judicial district encompassing 46 counties in Northwest Georgia, including metro Atlanta. He served as U.S. Attorney for almost five years before his appointment to the bench, overseeing many major cases including the successful prosecutions of former Atlanta Mayor Bill Campbell, the three Atlanta Police narcotics officers who conspired to violate civil rights by falsifying search warrants, resulting in the police shooting death of 92-year old Kathryn Johnston, and the first Georgians convicted of providing material support to international terrorism.

Chief Justice Nahmias has received numerous local, state, and national awards and honors for his public service. He has served on several committees and boards related to improving the legal system and the community. His wife, Catherine O'Neil, was a partner at King & Spalding and also a former federal prosecutor and senior Justice Department official. She passed away in 2017. Chief Justice Nahmias has two teenage sons.













### TERRICA REDFIELD GANZY



Terrica Redfield Ganzy is the Southern Center for Human Rights' (SCHR) Deputy Director, where she elevates SCHR's mission through public speaking, writing, and community engagement, assists the executive director with coordination of SCHR's strategy and programs, designs and leads SCHR's development strategy and development team, and builds strategic partnerships.

Prior to becoming SCHR's Deputy Director, Terrica was SCHR's Development Director for four years and a Staff Attorney in SCHR's Capital Litigation Unit for nine years, where her work focused on representing clients on death row in Georgia and Alabama. For five years, she also served as the National Association of Criminal Defense Lawyers (NACDL) Death Penalty Resource Counsel, providing training and resources to capital defense attorneys throughout the nation.

Terrica received her J.D. from the University of Virginia School of Law and an LL.M. in trial advocacy from Temple University Beasley School of Law. She received a B.A. in English and Humanities,

summa cum laude, from Tougaloo College. She received a Certificate in Nonprofit Management and Social Enterprise from Georgia State University's Andrew Young School of Public Policy. She is admitted to practice law in North Carolina, Alabama, Georgia, the Georgia Court of Appeals, the Supreme Court of Georgia, and the United States Supreme Court.

Terrica is a member of Leadership Atlanta Class of 2022, a graduate of Leadership Clayton, a member of the 2015 Class of the Georgia Center for Nonprofits' High Potential Diverse Leaders, a 2014 New Leaders Council Fellow, and a graduate of Georgia's WIN List's Leadership Academy. She serves as Vice-President of the Center for Death Penalty Litigation's Board of Directors, as Mentoring Co-Chair for the Atlanta Chapter of the Association of Fundraising Professionals (AFP), and as Vice-President of the Georgia Association of Black Women Attorneys' (GABWA). Terrica also serves on the State Bar of Georgia's Professionalism Committee and Seeking Equal Justice and Addressing Racism and Racial Bias Committee as well as the Judicial Council of Georgia's Access to Justice Committee.














### JIM HOGAN

He was also awarded the Sprayberry High Football Collage Event Award, which recognizes an outstanding Alumni who has brought credit to his school and himself, while being an asset to his fellow man. Shortly after graduating, Jim entered the U.S. Army, and was assigned to the 28th Air Defense Artillery Group and Forces Command. He received an Honorable Discharge after serving his country from 1973-1976. Jim and his wife, Amy, have seven children. They are active and engaged members of the Burnt Hickory Baptist Church, where they have led Adult and Children's Sunday School Classes.













### **PAULA FREDERICK**



Paula Frederick is General Counsel for the State Bar of Georgia, a unified bar organization with over 52,000 members. As General Counsel Ms. Frederick is responsible for interpreting the ethics rules for lawyers, prosecuting lawyer discipline cases, and providing legal advice to the officers and directors of the organization. She has served in the Office of the General Counsel for 33 years and was Deputy General Counsel for Discipline before becoming General Counsel in 2009.

Ms. Frederick is a 1982 graduate of the Vanderbilt University School of Law and a 1979 graduate of Duke University. Prior to joining the Office of the General Counsel, she spent six years as a staff attorney with the Atlanta Legal Aid Society handling civil legal matters for low-income people. Ms. Frederick is a Past President of both the Atlanta Bar Association and the Georgia Association of Black Women Attorneys.

She is also an active member of the American Bar Association, where she serves in the House of Delegates. She is Chair of the Coordinating Council of the ABA Center for Professional Responsibility and recently

chaired the Standing Committee on Professional Regulation. In the past she served on the Commission on the Future of Legal Services, chaired the Standing Committee on Ethics and Professional Responsibility and the ABA Diversity Center, and served as a member of the Board of Governors.













### WILLIAM GENTRY



William (Bill) Gentry has been practicing law in Georgia since 1986 and has been a member of the Cobb County Bar Association since 1988, the State Bar of Georgia since 1986, and the American Bar Association. Bill has been a member of the Board of Governors of the State Bar of Georgia since 2012, and he was elected to the Executive Committee of the State Bar in 2021.

For the last several years, Bill has led the Senior Lawyers Committee, which has created the Sudden Health Crisis Web Portal and worked alongside the Office of General Counsel to create a "Retired" membership status within the State Bar, among other initiatives. He also served as President of the 1,000-member Cobb County Bar Association from 2001 to 2002.

Bill is admitted to and has argued in the Georgia Supreme Court and the Georgia Court of Appeals as well as the 11th Circuit U.S. Court of Appeals in Atlanta. Bill is also a member of the bar of

the United States Supreme Court. He is a Phi Beta Kappa graduate of the University of Virginia's Economics Honors Program, where he earned his BA degree in 1981. Bill earned his law degree from the University of Georgia in 1986. ### HON. LATISHA DEAR JACKSON



The Honorable LaTisha Dear Jackson was elected as a Superior Court Judge of the Stone Mountain Judicial Circuit on July 24, 2018. Immediately before her election, Judge Jackson was a Senior Associate with the oldest minority owned law firm in the State of Georgia, Thomas Kennedy Sampson & Tompkins, LLP ("TKST"). There, Judge Jackson served in the litigation department defending corporate clients in medical malpractice, wrongful death, premises liability, and insurance matters. She also represented individuals in personal injury and wrongful death matters. Prior to joining TKST, Judge Jackson served as a fulltime judge in the DeKalb County Recorder's Court, where she primarily presided over traffic offenses, misdemeanors and county ordinances. From 2014-2018, Judge Jackson sat by designation in both the Superior and State Courts of DeKalb County. For over a decade, Judge Jackson served as a judge in local courts. In 2008, she made history by becoming both the first female and youngest judge to ever serve as a Municipal Court Judge in the City of Stone Mountain. In 2012, she again made history by becoming the first female Chief Municipal Court Judge in the City of Lithonia.

Prior to becoming a member of the judiciary, Judge Jackson was an attorney and counselor at law with her own law practice located in the historic City of Stone Mountain, where she specialized in all areas of juvenile law, criminal defense, family law and handled several high-profile cases. Judge Jackson has also served as an Assistant Solicitor General for DeKalb County's Office of the Solicitor-General, where she served as a trial attorney representing the State of Georgia on various misdemeanor crimes and habeas corpus proceedings. Judge Jackson earned her Juris Doctorate from Georgia State University College of Law, where she served on the Student Bar Association, as the Second Vice-President for the Southern Region of the Black Law Students Association, a member of the Phi Alpha Delta Law Fraternity and a Who's Who of American Law Students. She obtained her undergraduate degree from the prestigious Spelman College, graduating with a Bachelor of Arts in Economics (Pre-law concentration) and a double minor in Management Organization and Writing.

A native of Los Angeles, California, Judge Jackson is active in numerous professional organizations. She is a current member of both the Georgia Association of Women Lawyers and Georgia Association of Black Women Attorneys' Judicial Applicant Review Committees. In 2014, Judge Jackson was appointed by the Chief Justice of the Supreme Court of Georgia to serve on its Access to Justice Committee, where she continually works to ensure that there is unfettered access to the courts by litigants and the public as they navigate the judicial system. She is also a member of several bar associations which include but are not limited to DeKalb Bar Association and Gate City Bar. Judge Jackson also led the DeKalb Lawyers Association where she served an unprecedented two-year term as President. Presently, Judge Jackson is the President of the State Bar of Georgia's Judicial Section and a past president of the Georgia Council of Municipal Court Judges. Judge Jackson has also served as a voting member of the State's Judicial Council. In all that she does and has accomplished thus far, Judge Jackson remains humbled, inspired and motivated to continue to seek justice because there are still so many lives left to be touched. Finally, but most importantly Judge Jackson is the proud wife of Gari B. Jackson.
