# JUDGE RHONDA KREUZIGER MODERATOR

Superior Court Judge Rhonda Kreuziger has presided over matters for the Griffin Judicial Circuit (which covers Fayette, Pike, Spalding, and Upson counties) since August 17, 2021. Prior to her appointment to this position by Governor Brian Kemp, Judge Kreuziger served as the Associate Juvenile Court Judge for the Griffin Judicial Circuit from August 2020 to August 2021. Judge Kreuziger also served as the Chief Judge for the Fayetteville Municipal Court from July 2018 until August 2020, on a part-time basis. While serving in this capacity, she continued to manage and operate The Kreuziger Law

Firm, P.C. that she established in June 2006. From its inception, until August 2020, she represented matters in the following areas of practice: Criminal Law; Domestic Relations/Family Law; Personal Injury; Landlord/Tenant; Breach of Contract; and Criminal and Civil Appeals to both the Georgia Court of Appeals and the Georgia Supreme Court. She was lead counsel in several jury and bench trials, serving as both prosecutor and defense counsel in criminal cases as well as counsel for plaintiffs and defendants in civil matters. She has served as Guardian ad Litem in Family Law cases for the Griffin Judicial Circuit and Coweta County and worked as a conflict attorney for the Georgia Public Defender Council for approximately eleven years. Her firm also served as the part-time Solicitor for two municipalities during the earlier years of her private practice.

Prior to starting the law firm, she served as an Assistant District Attorney for the Griffin Judicial Circuit from approximately 2002 until 2006. As an Assistant District Attorney, she prosecuted felonies and misdemeanors in Superior Court and served as the Juvenile Prosecutor for the Griffin Judicial Circuit. While working toward a Juris Doctor, she worked as a law clerk in two civil litigation firms, assisting with catastrophic personal injury claims and workers' compensation matters. During the last semester of law school, she interned in the Special Prosecution Division for the Office of the Attorney General for the State of Georgia.

Prior to becoming an attorney, Judge Kreuziger worked as a Forensic Serologist (analyzing rapes, homicides, and burglaries) with the North Louisiana Criminalistics Laboratory, in Shreveport, Louisiana; and subsequently in the field of Forensic Toxicology (working on the identification and analysis of drugs) for SmithKline Beecham Clinical Laboratories in Dallas, Texas. Judge Kreuziger received a law degree from John Marshall Law School in Atlanta, Georgia, and a Bachelor of Science in Microbiology from Northwestern State University in Louisiana.

Charles "Chuck" P. Edward "Eddie" Chase III is a Chief Assistant District Attorney for the DeKalb County District Attorney's Office. In that role, he oversees the prosecution of crimes against children, sexual assault, domestic violence, human trafficking, cold case, and crimes against the elderly and disabled adults. Prior to that role, Eddie was a Senior Attorney with the Association of Prosecuting Attorneys' Child Abuse Prosecution Project, based out of Washington, D.C., where he facilitated child abuse training and technical assistance at the state and national level. He is a former Chief Senior Assistant District Attorney with Fulton County District Attorney's Office in the Crimes Against

Women and Children unit. Prior to his career as a prosecutor, he was a Staff Attorney with the Fulton County Public Defender's Office and with the Public Defender's Office for the 9<sup>th</sup> Judicial Circuit in Florida. In those roles, he defended the rights of indigent criminal defendants charged with felony offenses. He currently serves as the co-chair for the Georgia Statewide Child Abuse Expert Committee, is a member of the National Advisory Committee for Child Abuse, and serves as faculty for the National Children's Advocacy Center, Association of Prosecuting Attorneys, Prosecuting Attorneys' Council of Georgia, Aequitas, and Georgia's Child First program.

Recently, Francys was the 2018 Democratic Nominee for Georgia's 12th Congressional District.

A graduate of Georgia Southern University and the University of Georgia School of Law, Francys previously served on the Political Science and Criminal Justice faculties at Georgia Southern University and Savannah State University, teaching courses on Criminal Law, Constitutional Law, Race and the law, and the Civil Rights Movement. Today, he is a recognized thought leader on voting rights, having testified before Congress, lectured across the country, and written on other subjects, including race, measuring equity, and understanding power in public policy.

# RANDAL "RANDY" McGINLEY

Governor Jones and the Senate Committee on Appointments appointed Randy to the Prosecuting Attorneys Qualifications Commission where his fellow commission members elected him to serve as the Chairman of the Investigative Committee. He is also the current Vice President of the District Attorneys Association of Georgia.

In addition to supervising a staff of over 70, including over 20 Assistant District Attorneys, Randy handles numerous serious and high-profile prosecutions every year. This includes trying cases within his circuit and outside his circuit as an appointed conflict prosecutor.
