KENNETH "KENNY" MITCHELL, JR. MODERATOR

Attorney Kenneth Mitchell, Jr. is a graduate of Georgetown University and American University Washington College of Law. He currently serves as the Chief Assistant Solicitor General for the Cobb County Solicitor General's Office for Solicitor General Makia Metzger. At the solicitor's office, Chief ASG Mitchell supervises more than 75 employees (including 30 attorneys) and is responsible for managing all misdemeanor prosecutions for Cobb County, the state's third largest county.

During his career, Attorney Mitchell has handled hundreds of criminal cases and the majority of these involved serious criminal allegations. Attorney Mitchell began his career as an Assistant District Attorney with the Fulton County District Attorney's Office, the largest prosecutor's office in the Southeast. As an assistant district attorney, Attorney Mitchell represented the State of Georgia in a number of jury trials; and gained experience prosecuting homicides, sex crimes, and violent felonies. For his work, Attorney Mitchell was named Division Attorney of the Year three times for his trial advocacy and earned placement in Fulton County District Attorney Office's Major Case Division, which prosecuted homicides and high-profile cases in Atlanta. Upon leaving the District Attorney's Office, Attorney Mitchell went into private practice where he continued to serve as a zealous advocate in the courtroom and has successfully represented a number of clients in the Metro Atlanta area in criminal defense and business litigation.

Attorney Mitchell serves as the 78th President of the Young Lawyer's Division of the State Bar of Georgia, which represents more than 10,000 attorneys in the State. As YLD President, he oversees the service projects of the State Bar of Georgia and supports initiatives for all young attorneys in the State. As YLD President, Attorney Mitchell is also a member of the Executive Committee of the State Bar, which consists of more than 50,000 attorneys in the State.

Attorney Mitchell is also very active with the Georgetown University Alumni Association, where he has served as President of the Georgetown Club of Atlanta. For his service to Georgetown, Attorney Mitchell received the 2024 William Reynolds Young Alumni Award. Samantha was recently selected to be a part of the newest Leadership Academy class through the Young Lawyers Division of the State Bar of Georgia. She recently stepped into the Vice


Chair position for the Law School Orientations Committee for the Committee of Professionalism for the State Bar of Georgia.

Cathy's legal career began in the New York and London offices of Sherman & Sterling and continued to positions of increased leadership at the National Basketball Association, Turner Broadcasting System and EarthLink. She led award-winning law departments as Chief Legal Officer for RARE Hospitality and the City of Atlanta before

returning to corporate practice at Womble Bond Dickinson. Cathy has served as an Independent Corporate Board Director at Ameritech Facility Services for two decades.







Judge Glenda Hatchett

Judge Glenda A. Hatchett (Retired) is not only a world-renown judge, but she is a prominent attorney with more than 40 years of experience which encompasses a multitude of legal responsibilities. Currently, Hatchett is Of Counsel with the law firm of Stewart Miller Simmons based in Atlanta, Georgia, handling cases throughout the nation, specializing in wrongful deaths, catastrophic injuries, maternal deaths, tractor-trailer accidents, premises liability, products liability, sexual assault, and catastrophic police misconduct cases.

A graduate of Mt. Holyoke College and the Emory University School of Law, where she was an Earl Warren Scholar, Hatchett

completed a prestigious federal clerkship in the United States District Court, Northern District of Georgia, where she was the first Black clerk in that federal court. Hatchett then spent nearly 10 years at Delta Air Lines, where she was the airline's highest-ranking woman of color worldwide. As Senior Attorney, she represented Delta Air Lines in labor/personnel, antitrust litigation, and commercial acquisitions. As Public Relations Manager, she supervised global crisis management and handled media relations for 50 U.S. cities, Europe and Asia. Hatchett was appointed to a judgeship in 1990, becoming Georgia's first Black Chief Judge of a State Court in the state's history. There, she presided over Fulton County's Juvenile Court, one of the largest juvenile court systems in the nation. Hatchett gained national recognition for her groundbreaking initiatives for juvenile reform.

Hatchett served as Co-Counsel in the civil wrongful death case of Bobbi Kristina Brown in 2016, resulting in the judgement of \$36M in damages to Brown's estate. She gained global attention while representing the family of Philando Castille following his death in 2016. Philando Castille's death marked the first time in the history of the state of Minnesota that a police officer was indicted for killing a citizen. During that time, Hatchett strongly advocated that a special prosecutor be appointed to seek an indictment against the police officer who killed Castille. She was also instrumental in having the U.S. Attorney open an investigation for racial profiling at traffic stops for the entire state of Minneapolis.

She founded Hatchett Consulting Group, specializing with over 40 years of combined experience as an attorney, judge, crisis management expert, mediator, and television talent in legal issues and consulting in the areas of crisis communications and risk management. She also presided over the two-time Emmynominated show Judge Hatchett, which is in its 23rd season of national syndication (Sony Pictures Television). She continues to provide legal commentary on networks such as CNN, MSNBC and FOX. Most recently, Hatchett has returned to TV with her new television court series, The Verdict With Judge Hatchett. She presides over the series as a follow-up to Sony's long-running Judge Hatchett. Hatchett is also the author of the National Best Sellers, Say What You Mean and Mean What You Say (Harper Collins, 2003) and Dare to Take Charge (Center Street / Hachette Book Group, 2010).

Hatchett has served on various nonprofit boards, including the National Board of Governors of the Boys and Girl Club of America, the Leadership Circle for the After School Alliance, and the Advisory Board for the Women's Resource Center at Spelman College. She formerly served on the Board of Advisors for Play Pumps International. Presently, Hatchett serves as the national spokesperson for CASA (Court Appointed Special Advocates), a nonprofit volunteer organization that trains volunteers to represent abused and neglected children.







Judge Robert McBurney

Judge McBurney has served on the Superior Court of Fulton County since April 2012. He survived a stint as Chief Judge from 2018 to 2020. He is also one of the Court's two drug court judges -- a role which allows him to help people rebuild lives harmed by addiction.

Before joining the bench, Judge McBurney served as an Assistant United States Attorney in Atlanta. As a federal prosecutor, he focused on cases involving public corruption, terrorism, and child exploitation.

Judge McBurney received his B.A. and J.D. from Harvard. Prior to his time in public service, he

worked as a management consultant for McKinsey & Company. Judge McBurney lives in Atlanta with his wife, who is the head of leadership development at McDonald's, two wonderful (and exhausting) boys, and two equally troublesome dogs.





Judge Eric Richardson

Governor Nathan Deal appointed Judge Eric Richardson to the Fulton County State Court in August 2013. In May 2022, Judge Richardson was elected without opposition to a third four-year term. As a State Court Judge, he presides over misdemeanor criminal cases, including DUI and domestic violence offenses. Judge Richardson also presides over a wide variety of civil cases, including medical malpractice, products liability, fraud, complex business disputes, and personal injury actions.

Judge Richardson earned his Bachelor's degree in philosophy from the University of Rochester. He earned his law degree, cum laude, from Cornell Law

School. Judge Richardson began his legal career as a litigator at Latham & Watkins in New York City in 1994. In 1998, he relocated to Troutman Sanders in Atlanta, where he spent 11 years, including 7 as a litigation partner. In 2009, he moved to the public sector, joining the city of Atlanta as a Senior Assistant City Attorney. He was promoted in 2011 to Deputy City Attorney, where he managed all litigation for the City until his appointment to the bench.

Judge Richardson lives in Johns Creek with his wife of 34 years, Karen, and has three adult children.
