### **INFORMATION ON OBTAINING CLE CREDIT**

The Commission will submit attendance information to the State Bar of Georgia's CLE Department for Georgia Bar members who attend the entire 1.0 hour CLE not more prior to March 31, 2025, AFTER the Commission confirms your participation in the CLE via the Zoom.us reports. There may be a delay in reporting CLE attendance for attendees who do not attend the entire CLE because it takes more time to calculate and report partial attendance.

To maintain the CLE credit on your CLE transcript, please visit [www.gabar.org](http://www.gabar.org) and click on the "Member Login" Button in the top right-hand corner. After you are logged in, look for the Blue "My Account" Box to the left. Click on the first link, "CLE Status." If you attended the entire CLE, the Commission will send your attendance report to the State Bar of Georgia prior to March 31, 2025, the Commission confirms your participation in the CLE via the Zoom.us reports. There may be a delay in reporting CLE attendance for attendees who do not attend the entire CLE because it takes more time to calculate and report partial attendance.

Once the Bar receives your attendance report, you will have the option to pay the \$4 per CLE hour fee to have the CLE remain on your transcript. The fee is not due until December 31<sup>st</sup>, so please do not be alarmed if you do not immediately see an amount due on your transcript that allows you to pay.
