## What is the CJCP's Grants Program?

The CJCP currently offers grants to organizations that promote, enhance, improve, and/or develop legal professionalism in Georgia. The Commission can suspend grant-making at any time for any reason, and is creating no vested rights in grants.

## What Types of Programs Can Receive a CJCP Grant?

CJCP grants are awarded to eligible programs that relate to the regulation of the legal profession; encourage professionalism (competence, civility, and character, etc.) among Georgia's lawyers and judges; provide CLE seminars that highlight legal professionalism; and are centered on enhancing access to justice or improving the administration/operations of the legal system. Both new and existing/ongoing programs can receive funding, but priority will be given to new programs. Full information regarding the CJCP's grant criteria can be found <a href="here">here</a>.

## What Organizations are Eligible to Apply?

Charities/nonprofits organized under section 501(c)(3) of the Internal Revenue Code, law schools and law-related educational programs, courts, and local or voluntary bar associations are eligible to apply for CJCP grants.

## When will 2025 Applications Be Available? What is the Submission Deadline?

Applications will be available online at the CJCP's grants <u>webpage</u> on or about June 9, 2025. The submission deadline for applications, including all required materials, is July 15, 2025.
